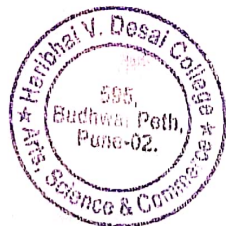
- 1) Permissible posts are determined based on workload calculations derived from the enrolment figures of students within the aided faculty/department/subject of the college.
- 2) It is mandatory to furnish data on faculty/division/subject-wise student enrolment as outlined in the college's submission for appointment, along with the university-approved intake capacity.
- 3) Workload calculations have been computed considering the requisite student count for grant eligibility.
- 4) Compliance with the government-stipulated batch size for practicals is mandatory.
- 5) Prescribed hours for Lectures/Demonstrations/Tutorials, and Project Work must adhere to the norms established by the Government.


- 6) Validation of the reservation point list by the designated authority, in accordance with prevailing government reservation policies, is mandatory for sanctioned college posts.
- 7) The permissible number of posts will be adjusted in case of a decrease in student enrolment in subsequent academic years or if the aided department's workload diminishes for any reason.
- 8) Surplus teacher/non-teaching staff adjustments must be executed in line with existing government resolutions. Recruitment without the integration of surplus staff will not be authorized.
- 9) Posts have been sanctioned based on the grant-eligible workload of the college. Recruitment for sanctioned posts necessitates the submission of a proposal and acquisition of a separate No Objection Certificate, in accordance with relevant government policies and procedures.
- 10) Recruitment for sanctioned posts must adhere to the Government's recruitment policy. Recruitment without prior permission (i.e., without a No Objection Certificate) is prohibited. Any irregularities in appointments, or appointments made without proper authorization, will result in the disallowance of salary payments for said posts. The college's management bears sole responsibility for such appointments.
